# **Honour Clauses** (*Terms and Conditions*)

### **Non-Commercial Tour**

I acknowledge that Steve undertakes his private tours on a non-commercial basis, and does not trade as a business, nor as a commercial tour operator, nor as a club, nor as a charity. I acknowledge that Steve is currently pursuing his hobby a rranging private tours offered to participants as friends on a private and informal basis.

Steve charges no fees. Invited participants must self-fund their own participation voluntarily, yet are also welcome to contribute nominal contributions to cover direct costs of any participation on a tour.

### **Minors Not Permitted**

Participants under the age of 18 years are not permitted to participate on any of Steve's private tours due to unacceptable heightened risks in the outdoors environment in which we operate and due to liability insurance prohibitions. We refer parents to our competition.

# Participant Acknowledgement of Risks and Obligations

I acknowledge that Steve's private tours are outdoors activities which include bushwalking which poses inherent hazards, risks and rigors that may cause injury, illness or death or to loss of or damage to property. I acknowledge my participating in bush walking potentially carries the risk of harm of personal injury or death. I acknowledge and accept that my presence at and participation on any of Steve's Private Tours shall be entirely at my own risk.

I acknowledge that in participating on any of Steve's private tours, in order to minimise risks I will endeavour to ensure that

- 1. Each activity is within my capabilities,
- 2. I shall wear appropriate clothing as advised by the Tour Leader
- 3. I shall carry food, water and equipment and clothing appropriate for the activity.
- 4. I shall advise the Tour Leader if I am taking any medication or have any physical or other limitation that might affect my participation in the activity.
- 5. I shall make every effort to remain with the rest of the party during the activity
- 6. I shall advise the leader of any concerns I am having, and
- 7. I shall comply with all reasonable instructions of the Tour Leader.

### **Failure to Show**

It is the responsibility of a booked participant on each given tour to show up at the designated **Tour Start Location** and **Scheduled Meet Time** – a ppropriately dressed and equipped as specified by the Tour Leader, as well as being fit, well-rested, fresh and sober.

It is the responsibility of a booked participant if for any reason they feel unwell, unfit or in any way unable to participate competently, that they immediately notify the Tour Leader by phone on the mobile number at the top of this agreement.

Please keep your Tour Leader informed if you have any changes to your booked participant attendance – number or request to exchange an individual.

As sume that tours publicised on the Steve website under the current seasonal programme are to proceed as described, unless you are informed otherwise by Steve – typically by phone to booked participants in the first instance, with a follow up email explanation.

Do not assume that your tour is cancelled because of inclement weather.

### **Tour Numbers**

The minimum participant number on any tour is one (1) plus the Tour Leader. We will proceed on a tour with one participant, up to a maximum of six, plus our Tour Leader. This limit is recommended by National Parks Service for ecological and risk management reasons, and we happily comply.

Please keep us informed of any changes to the numbers in your party. An increase in numbers may not always be possible. To avoid disappointment, notify us of changes as early as possible.

# **Dangerous Weather Policy**

The Tour Leader will normally operate in all but exceptional weather conditions. Conditions such as fog, mist drizzle, showers, rain, sleet and moderate wind do not affect normal operation of our tours.

As sume that your booked tour shall proceed as scheduled unless you are informed otherwise by the Tour Leader by phone. Steve will make every effort to notify booked participants if there are delays, postponement, rescheduling, variations or cancellation well in advance of a given tour.

I acknowledge and agree that the Tour can and will be affected by the weather and that the weather conditions may change without warning. I understand that the Tour Leader may need to cancel, halt, delay or re-route the Event in response to hazards induding extremes of weather, fire, flood or path instability. Where possible the Tour Leader will attempt to preserve the nature of the tour.

There are 5 specific weather dangers that for safety reasons will likely cause a tour to be cancelled.

- 1. Bushfire risk rated as 'Extreme' or worse, and /or an active bushfire in the region
- 2. Forecast/Actual risk of lightning strike
- 3. Forecast/Actual high winds gusting a bove 60kph, when clifftop walking is involved
- 4. Forecast/Actual snow
- 5. Forecast/Actual maximum temperature above 35 degrees Celsius

# **Conditions of Participation**

Participants agree to act in a safe and appropriate manner while using the facilities and services provided, and to abide by all directions given by the Tour Leader. Any equipment loaned to a participant for a tour must be returned by the participant to the Tour Leader at the **Tour Finish**.

Participants who arrive at Tour Start without approval of the Tour Leader shall be automatically denied participation on the tour, without exception. Steve reserves the sole right to cancel any tour for any reason, to alter our tours (including but not limited to starting times, pricing, inclusions or itinerary) at any time for any reason without notice, and deny access to tours for any participant for any reason.

Steve reserves the sole right to refuse any participant applicant for any tour and will advise the individual directly of the reason in strict confidence. The timing of refusal may be upon Steve receiving an intending participant's completed application form, in which case a notice of refuse by email shall be sent by Steve to the intending participant. The timing of refusal may also be at the **Scheduled Meet Time** where by the Tour Leader at his/her complete discretion considers an intending participant unwell, unfit, is objectionable or ina dequately dressed and equipped to safely and competently undertake a tour.

Steve reserves the sole right to remove a participant from any tour for any reason. Steve shall not be liable for any additional expenses incurred as a result of rejecting an intending participant, or the removal of an actual participant from a tour.

Justification for rejection/removal includes, but is not limited to, anyone who in the opinion of the Tour Leader is considered to ignore/disobey directives of the Tour Leader or assistant staff, be affected by a lcohol or drugs, is disorderly, poses a hazard to themselves or to others, is abusive, appears not physically able, mentally problematic, or is objectionable in any way.

# **Fitness to Participate**

I declare that I am medically and physically fit and able to participate in any tour. I shall immediately notify the Tour Leader (prior to any booked tour and/or during participating on any tour) of any change to my medical condition, fitness or a bility to participate. I understand and a ccept that Steve will continue to rely upon this declaration as evidence of my fitness and ability to participate.

### **Emergencies**

Each participant personally a cknowledges that they may encounter weather conditions that could lead to hypothermia and being in locations where evacuation for medical treatment may take hours or days.

In the case of medical emergency, I understand every effort will be made to notify the emergency contact named on this form. In the event that the emergency contact cannot be reached, I hereby give permission for the Tour Leader to communicate personal information provided by me on this agreement to the attending medical authorities and for the attending medical authorities to make emergency decisions for me. In the event medication, medical advice, treatment and/or equipment or transportation is required, I agree to accept full financial responsibility.

# **Health Insurance**

The participant accepts that a dequate health and trip interruption insurance is his/her responsibility. The participant must have their own private health insurance including the cost of emergency and ambulance services, as well as their own travel insurance.

# **EcologicalRespectonTour**

Steve chooses to conduct most of its walking tours in the Greater Blue Mountain World Heritage Area. This valuable natural environment sustains our tour venture. Many of our tours are conducted in ecologically sensitive sanctuaries that we undertake to safeguard as we pass through. It is a condition of participation on a tour that '*we leave no trace*' of us having been there except for incredible photos and magic memories. Please do not interfere with, pick up, alter or remove any plant, a nimal or other natural, his torical or cultural feature. Please keep to formed tracks, carry all your rubbish out with you and use minimal impact toileting procedures should 'nature call'.

# **Security and Privacy**

At Nature Trail we take participant security and privacy very seriously. All participant data is stored securely at Nature Trail base off-line. We will take all reasonable steps to protect your personal information supplied. This includes a ppropriate measures against unauthorised access, modifications, misuse and disclosure.

Consistent with Australia's Privacy Act and Australian Privacy Principles guidelines, all personal information a bout an intending/accepted participant provided in this agreement is retained securely by Steve. We will take reasonable steps to destroy or permanently de-identify personal information if it is no longer required. This destruction of personal information will be by secure means, for example shredding, pulping or disintegration.

Personally identifiable information is stored on computers that are not publicly a vailable. Further, personally identifiable information is only a ccessed by APT's employees on a 'need-to-know' basis. Credit Card details are NOT stored on our database when you book, or buy products on our site.

### **Exclusion of Liability**

Whilst Steve and or any associated third party to a tour will take all reasonable steps to deliver an enjoyable tour as advertised, there is no acceptance of liability for any loss of enjoyment experienced by participants due to circumstances beyond the Tour Leader's control. Steve shall not be liable for any additional expenses relating to any tour, including but not limited to: cancellations, missing connecting transport, extra accommodation, or food expenses. All additional expenses incurred on a tour shall remain the sole responsibility of the participant.

Steve will as part of its tour offering from time to time use the services of other operators – caterers, site guides, commentary subject experts, tourism operators, transport operators, etc - and whilst Steve takes all reasonable care in selecting these operators, it cannot a ccept responsibility for those operators conduct or the conduct of their representative employees or agents or any ramification of that conduct.

I acknowledge that where I am a consumer of recreationals ervices, as defined by any relevant law, certain terms and rights usually implied into a contract for the supply of goods or services may be excluded. I acknowledge that these implied terms and rights and any liability of Steve flowing from them, are expressly excluded to the extent possible by law, by this declaration.

### **Release and Indemnity**

In consideration of Steve a ccepting my participation on any tour, I: (a) release and will release the Provider from all Claims that I may have or may have had but for this release a rising from or in connection with my participation on any tour; and (b) indemnify and will keep indemnified Steve to the extent permitted by law in respect of any Claim by any person arising as a result of or in connection with my participation on any tour.

In consideration of the above tour being provided for no fee, as an invited participant on any of Steve's private tours, I for myself, my heirs, executors, and a dministrators, hereby waive all or any claim, right or cause of action which I or they might otherwise have for or a rising out of loss enjoyment, loss of life or injury, damage to or loss of property or of any description whatsoever which I may suffer or s ustained on any tour and activities undertaken in connection therewith. I a cknowledge the risks and I will take responsibility for my own actions and that signing this a greement will be deemed as full a cceptance and understanding of the above conditions. I have provided the information required. In voluntarily signing this a greement, I coven ant and warrant that (a) all information provided is true and correct; and (b) I have read, understood, acknowledge and a gree to the above declaration including but not only the warning, exclusion of liability, release and indemnity.
